Presidents' Messages

Dear Alumnus,

As we begin celebrating the centennial year, what better theme than "Hard Work U – A Tradition That Works." The "Hard Work U" moniker was pinned on the College in a Wall Street Journal article over 30 years ago, and The School proudly adopted this descriptive nickname. However, long before that article was written, graduates of The School of the Ozarks were noted for success in business and

education because of their strong work ethic, an attribute developed by a tradition that works.

When Reverend James Forsythe conceived the idea of a school in the Ozarks, hard work was part of his vision. He was impressed by the strong work ethic in the Ozarks and saw many young people deserving of a Christian education, yet without sufficient means. He believed work should be part of the learning process and birthed the idea of a work school.

Thomas Edison once said, "The reason most people don't recognize opportunity is because it usually goes around wearing overalls and looking like hard work." I believe College of the Ozarks students recognize opportunity before they come to campus. If they don't, they certainly learn to recognize it by participating in this tradition that works.

Helen Youngblood shared results of an Alumni survey with me recently. The 2005 survey asked 22 questions of 226 graduates of the class of 1995. Of respondents, I was pleased to see:

- 100% agreed or strongly agreed the mission of the college was clearly stated and carried out.
- 100% agreed or strongly agreed the overall quality

of education offered was excellent.

- 100% agreed or strongly agreed students were encouraged to have a wholesome attitude toward their country, its ideals, principles and laws.
- 100% agreed or strongly agreed the work study program helped with the cost of education.
- •97% agreed or strongly agreed work experience helped gain self-confidence and maturity.
- •97% agreed or strongly agreed Christian living was fostered by the college community.
- •95% agreed or strongly agreed the work study program promoted healthy attitudes toward work and dignity of work.
- •94% agreed or strongly agreed Alumni feel a strong responsibility to support the College.

Thank you for your support of the College. We were all blessed by this tradition that works. There are still young people deserving of a Christian education, yet without sufficient means. Please give generously so others may have the same opportunities we had.

Remember our goal of \$250,000 to renovate the Alumni Laundry, provide new equipment, and air condition the facility for the first time. The laundry was the first project undertaken by Alumni on the campus 45 years ago. We want this facility to be something that all alumni can be proud of. We plan to rededicate this facility at Homecoming 2007.

Let me encourage you to make plans to participate in Homecoming 2006. The festivities start early Saturday morning with the Walk/Run at 7:00, Alumni Breakfast at 8:00, and the Alumni Annual Meeting at 9:00. I look forward to seeing you.



Richard Miller '73 — Distinguished Achievement

Richard Miller received his Bachelor in Business Administration from The School of the Ozarks in 1973. He also attended SMS, Drury, American Institute of Banking, American Bankers Association National Commercial Lending Graduate School and the American Bankers Association National Compliance School at University of Oklahoma.

While attending S of O, he served as President of the Collegiate Affiliation of Business Students, Senior Class President, and he ran track and cross country for three years. As a student in the work program, he worked for Mrs. Winfrey in the Business Department.

Richard oversees many activities and programs as the Minister of Stewardship and Financial Development at Second Baptist Church in Springfield, where he has been a member for 28 years. He has served in various positions in the ministry, including Deacon and Treasurer. He is also the Investment Manager for a local equipment company.

Richard served Boatmen's Bank for 28 plus years retiring as Vice President. His focus as a consultative banker was "trying to help make life better for people and businesses by helping them reach goals and succeed."

Richard is currently the President of the Alumni Association at College of the Ozarks, previously holding the positions of President-Elect and Treasurer. He has served as President of the Springfield Alumni Chapter and Winfrey Business Alumni Chapter. In addition, he has served as President of the Southwest Missouri Chapter of the American Institute of Banking and is a member of the Fellowship of Christian Athletes Adult Chapter. Richard is also a 1997-1998 graduate of Leadership Springfield.

At his church, he is Director of Go Team, which assists first-time visitors to the church, and for over 20 years, he was a Youth Sunday School teacher. Richard has served his community as a Salvation Army Advisory Board Member for 17 years and is currently

Christmas Committee Chairman. He is also a member of Gideons International, serving as Memorial Bible Chairman. For 28 years, he has been involved with the Kiwanis Club of Ozark Empire, receiving the Tablet of Honor Award and the Legion of Honor Award. He has been active in the fight against cancer by being involved in the American Cancer Society and the Relay for Life Committee. He served the Springfield Public Schools Foundation on the Telethon for Technology Committee and was the Race Director of that committee's 5K run for three years.

Richard says, "The greatest fruits of my labor are three children who know Jesus Christ as their personal Savior and honor Him in their lives." He also takes pride in his 32-year marriage to Carolyn, who he met his first week at S of O. Richard also thanks God for his ability to spend time with others without the craving for personal gain.

Since his retirement from banking, Richard has the time to go on short-term mission projects. He has been on missions to Costa Rica, Guatemala, and Panama on "Operation GO (Gospel Outreach)" trips and various other mission trips. In 2004, he participated in a Gideon distribution of 230,000 Bibles in Las Vegas. At Second Baptist, he also does financial counseling. He says, "Monetary return, status, and power are not my focus, but something bigger—significance and a positive influence on others. It is my desire to influence others for good that they might know our Lord and honor Him with what He has entrusted to them."

With the help of S of O, Richard was the first of three children to earn a degree. He says, "The work ethic I acquired growing up on a farm (picking up rocks and working in the fields) was enhanced by the focus of The School on hard work and has carried me throughout life in my work career, or extracurricular activities, and in leading or influencing others." Richard developed his self-discipline at S of O. He recalls one summer day when Coach Osburn asked him if he had run that day. He replied that he did not, but he planned to make up for it the next day by running twice. Coach said, "Rich, you could have run twice tomorrow anyway. You lost out on what you could have done today." That moment has stuck with Richard for 35 years; for that reason, he tries not to put off until tomorrow what he should do today.

Robert Ramey '95—Outstanding Young Alumnus

Robert Ramey graduated Summa Cum Laude with a degree in Aviation Maintenance Technology at College of the Ozarks in 1995. He attended Central Missouri State University, where he was honored as a Hemphill Outstanding Graduate Scholar Nominee and graduated as a 4.0 student with a Master of Science in Aviation Safety. While attending Central Missouri State University, he worked as a Graduate Teaching Assistant and Adjunct Professor for the Department of Power and Transportation. He continues his education annually at the General Aviation Air Safety Investigators Advanced Technical Workshops.

Robert has worked for Raytheon Aircraft Company in Wichita, Kansas, for the past ten years. He was recently promoted to Manager of the Air Safety Investigation Department, where he is responsible for assisting the National Transportation Safety Board, Federal Aviation Administration, U.S. Military, and foreign governments in the investigation of accidents involving the aircraft company's products, both domestic and worldwide.

Prior to accepting his management position, Robert served as an Air Safety Investigator for seven years. He has been involved in nearly 70 field investigations, both domestically and internationally. Additionally, he served as Party Coordinator for Raytheon Aircraft Company in two NTSB Major "go team" Investigations.

Robert began his career at Raytheon in the Liaison Engineering Department, a fast-paced environment that impacts delivery schedules of multi-million dollar aircraft. He credits C of O's work program and classroom environment for the invaluable skills and knowledge that he carried into that position.

Rob is a member of Beechcraft Employees Flying Club, holding the offices of First Vice-president and President, and currently serves as its Chairman of the Board of Directors. He is also a member of the Experimental Aircraft Association, Aircraft Owners and Pilots Association, and Professional Aircraft Maintenance Association. While attending C of O, he was the President of the Chi Omicron Chapter of Alpha Eta Rho. At CMSU, Ramey was the President of the Lambda Pi Chapter. He is also a member of Immanuel Baptist Church and a volunteer for the Kechi Fair Committee.

Robert says, "My greatest accomplishment (other than my family) is having a job I truly enjoy, and through that job, being able to, 'make a difference.' Aviation is not only my career, but my passion as well. In my position, I am able to identify and help solve issues that help to make air transportation safer and more reliable. Being able to make aviation safer for the traveling public, and recreational user, is very satisfying."

Regarding his C of O experience, he says, "I grew

up in rural Arkansas. After graduation from high school, I began working at a local manufacturing facility, as did many of my classmates. While there, I was able to further my lifelong interest in aviation by obtaining my Private Pilot Certificate. At this time, I started dreaming of a career in aviation. College of the Ozarks gave me the opportunity to fulfill that dream. The knowledge, work ethic, and drive for excellence, centered on the teachings of Jesus Christ instilled while at College of the Ozarks, have and will continue to serve me well. Maynard Wallace '63 JC Distinguished Community Service

Maynard Wallace received his Associate Degree in Science at The School of the Ozarks Junior College in 1963. He attended Southwest Missouri State University where he earned his Bachelor of Science in Education; at Central Missouri State, he earned his Master and Education Specialist Degrees.

Elected to the Missouri House of Representatives in 2002, Wallace serves his community as the State Representative of the 143rd District in Missouri. He is Vice-Chairman on two committees:

Appropriations–Education and Special Committee on Education Euroling. He also serves on the Higher Education

Education Funding. He also serves on the Higher Education Committee, Elementary and Secondary Education Committee, Joint Committee on Education, Local Government Committee, and Special Committee on Agri-Business.

For many years, Maynard organized and operated baseball and softball programs in various communities. The Red Cross has recognized him as a faithful blood donor and for getting others in the community involved in its blood donor program. He and his family attend the Thornfield General Baptist Church.

He is a lifetime member of the Missouri State Teachers Association and Missouri Association of School Administrators, serving as the Vice-President. He has also served as Vice-President of the Kiwanis Club, Forsyth Chamber of Commerce, and Bradleyville Alumni Association President.

During his career in education, Wallace served the public schools for over 33 years—seven years as a school teacher and coach, and 26 years as an administrator. For 20 of those years, he was a superintendent.

Maynard states, "There are more than a dozen people who have worked under my leadership who

have become superintendents of schools." He believes that his "common sense approach and treating everyone with respect has inspired others."

Regarding The School of the Ozarks, Wallace says The School "allowed me to get a college education without financial debt. The College reinforced the cornerstone upon which I was raised. That is, if a person is willing to work, has faith, is honest, and respects his fellow man, he or she will be successful."

Maynard and his wife, Linda, have three children, Michelle, Michael, and Nicole, all graduates of College of the Ozarks.

Dr. Mayburn Davidson

Distinguished Service to College of the Ozarks

Dr. Mayburn "Mabe" Davidson graduated from Gideon High School in 1958, and earned his Bachelor in Education degree from Southeast Missouri State. He earned his Master and Doctorate in Education Degrees at the University of Arkansas.

Dr. Davidson served as Dean of Work at College of the Ozarks for nearly 33 years, always working to improve the overall student work operation. He witnessed the work program grow to approximately 1,250 students. Dr. Davidson's duties also included supervising the switchboard, coordinating the display of campus flags, and assisting with major campus events.

From 1969-1971, he was the high school principal of Thayer High School. He said that being principal let him get his "feet wet," and it let him learn some of the basics in the educational administration field.

Dr. Davidson has been a member of Phi Delta Kappa educational fraternity, National Rifle Association, and was a trustee of the Missouri Baptist Children's Home. Since 1973, he has been an active member of the First Baptist Church of Branson, serving as an ordained deacon and on various committees, including the Personnel Committee, the Stewardship Committee, the Nominating Committee, and chairing the Pulpit Committee. He also worked in the nursery, sang in the choir, and served as a church trustee. Dr. Davidson has participated in fund-raising activities for Big Brothers-Big Sisters and the Baptist Student Union on campus.

In describing Dr. Davidson, President Davis said, "Dr. Davidson is a person of high character who exhibits patience and fairness. He is an honorable and hard-working man with a willingness to always lend a helping hand. Students and staff are fond of his memos or 'epistles' and his detailed voice mail messages. Dr. Davidson exemplifies the five-fold mission in his work and his personal life."

When asked about his greatest sphere of

influence, Dr. Davidson believes that it is his extensive contact with S of O/C of O students while serving as Dean of Work. He says, "It is not my work program, of course; it is the College's work program. But as I have worked with students in various situations over the years, it has been my privilege to see student after student after student 'grow up' at S of O/C of O, and develop into mature, productive students, ready to 'take on the world' after they leave."

Speaking of his C of O relationship over the last 32-plus years, he

comments, "Its values, in many ways, have become my values. I have learned much about the true meaning of the word 'service,' the attitude of working together for the betterment of the whole, of putting something else first, rather than one's own specific agenda, and of (at times) sacrificing one's time and energies (as well as time with one's family) in order to get a job done that needed doing. I never had a job before that I would put as much into as I have this job at C of O. The experience at College of the

Ozarks has been the overriding occupational experience of my life, and not just because of the extended time I have spent on the job here."

He also remarks, "I realize there just is no measuring the good accomplished here by the members of the C of O family. I wouldn't take anything for the experiences I have had here, and I thank God for the opportunity of having worked here."

Dr. Davidson and his wife, Cora, have one daughter, Jennifer, a C of O graduate.

Remembering a Work Tradition

Benjamin Foster Furniture Manufacturing Plant

In the late 1950s and 1960s, the furniture factory built church and school furniture for The School. Furnishings for churches were also manufactured and sold commercially. In the mid-1960s. Western Auto Supply Company made a contract with The School's furniture plant to make doll furniture and playground equipment. President Clark was astounded by the "ingenuity and skilled craftsmanship" of men The School had recruited from the area to help the student workers. These men could make "excellent furniture and woodwork from rough lumber" (Flight of the Phoenix 447).

James A. Jamison was the first Furniture Plant Manager. He came to S of O in 1952 when he was hired to make furniture for the dormitories and offices. After the new Benjamin Foster Furniture



Manufacturing Plant was built in 1959, Mr. Jamison came back to The School to supervise student workers in the facility.

Remnants of the creativity of the workers at the furniture plant can be seen in desks and closets still in use today in the dormitories and in the extensive woodwork in Lyons Library. But, the most astounding craftsmanship can be viewed in all of the intricate woodwork in Williams Chapel.

The furniture factory was phased out as a work station during the 1972 academic year.


L. W. Hyer Canning Factory



The School of the Ozarks began the first cannery operation in 1925. With the help of the American Canning Company of New York, who was leasing equipment to The School for one dollar a year, the first year's production was 18,000 cans of fruits and vegetables. As the canning production increased and a more permanent cannery

was needed, Mr. L. W. Hyer donated the money to build the Hyer Cannery in 1938. Built of native stone and concrete at a cost of \$52,000, the cannery (during its use) was the most up-to-date factory in the Ozarks. Under the direction of Johnnie B. Jones '37, who was the longest-serving cannery supervisor, the students produced an amazing 20,000 cans of product per day. The canning factory operated with 110 student workers until 1968, when it was closed and converted to the College Press operation. The canning schedule for the various products was kept on an old chalkboard which is on display in the Alumni Center. The writing on the board remains from the day the cannery closed.


