



Presidents' Messages

Dear Alumnus,

Congratulations are in order to the four 2007 Meritorious Award recipients. Dr. Roy Elfrink, Don Johnson, Angela Ussery Williamson, and Don Baker have distinguished themselves with great vocational accomplishments, community service, church participation, and commitment to College of the Ozarks and are worthy of our recognition.

We have some of the finest alumni of any school in the country. We should be very proud of our graduates in all walks of life. The character, values, and work ethic developed and nurtured at C of O are unsurpassed at any college or university in the country, in my opinion.

I've enjoyed reading Dr. Davis' book, "Miracle in the Ozarks" recently. I appreciated reading how much time Lady Margaret Thatcher spent with students at workstations when she visited the campus in 1997. What a tribute it was when she said. "I've read of the work and ideas of this unique college. And now that I have seen it, I'm not only tremendously impressed, I'm very enthusiastic about it...The education that you get here is not only an education or a qualification for a degree; it is an education for life... Now, my friends, what we learn is that the most important thing of all, wherever you are, is the values in which you believe and the values by which you live...Values are extremely important and matter more than anything else—the values and the traditional family."

AWARDS PROGRAM College of the Ozarks Alumni Association

The purpose of our awards program is to recognize outstanding achievements of alumni, faculty, and friends and to encourage interest in College of the Ozarks. The awards program for the Alumni Association is to broaden the scope of the Alumni Association's program to include faculty, friends, and students, in addition to Alumni.

Categories and Eligibility:

- 1. Meritorious Alumni Award for Distinguished Achievements—College of the Ozarks Alumni
- 2. **Distinguished Community Service Award**—College of the Ozarks Alumni
- 3. **Distinguished Young Alumni Award**—any College of the Ozarks alumnus who has graduated less than 20 years ago and is not older than forty-five
- 4. **Award for Distinguished Service to College of the Ozarks**—faculty, staff and administration, friends or any other worthy individual

Guidelines:

- 1. The nominee must be living at the time of notification of the Award selection and be present, if possible, at Homecoming to accept the award.
- 2. Nominees must show current and continued interest in College of the Ozarks.
- 3. Nominees must complete an official nomination form listing dates and achievements.

Selection of awardees is determined by the Honors and Awards Committee, appointed by the President of the Association every two years. The Honors and Awards report of selections is approved by the Alumni Council before awards are published. Nominees' files are kept active for two years following nomination.

While in graduate school, Elfrink also worked as a flavor chemist for Beck Vanilla Products. During his medical career, he has served as a clinical instructor at Harry S. Truman Veteran's Hospital, a volunteer surgeon at St. Mary's Hospital in Papua New Guinea, and is currently the Chief of Staff at Fitzgibbon Memorial Hospital and at his private practice, Elfrink Surgical, LLC.

Dr. Elfrink has written several medical reviews and articles that have been published in Missouri Medicine, Postgraduate Medicine, and the Journal of Vascular Surgery. He has given presentations at Fitzgibbon Memorial Hospital, University of Missouri-Columbia, and the Missouri Chapter of the American College of Surgeons. His professional affiliations include the Fellow-American College of Surgeons, American Board of Surgery, and the University of Missouri-Columbia Surgical

In his community, Roy has been a member of Big Brothers of Greater St. Louis, served on two special medical teams to Haiti, is a Charter Board Member with Habitat for Humanity, serves as a surgery preceptor for medical students at Kansas City University of Medicine, and also serves as a clearing house for donated medical supplies for use in third world countries. Among his personal achievements, he is a finisher of the Chicago Marathon (26.2 miles) and the Half-IronMan Distance Triathlon (2.4 mile swim, 56 mile bike ride, and 13.1 mile swim).

At his church, St. Peter's, Dr. Elfrink has served on the Social Concerns Committee, created and chaired the church's Development Committee, and co-chaired the Capital Campaign Committee,

which raised \$1.5 million for renovations on the school, church, and rectory.

Dr. Elfrink lives in Marshall, Missouri, with his wife, Melanie, a physician, and his six children, Jacob (17), Eden (15), James (11), Mary (9), Katherine (5), and Teresa (2). Of all of his accomplishments and achievements, Roy says, "My family is my greatest accomplishment."

He attributes his other accomplishments to the opportunity of attending The School of the Ozarks and the discipline that he learned. "I'm doing things I never dreamed I'd be able to do, and I am fortunate to serve people in many different ways," he says. "The values I grew up with were reinforced in good ways at S of O, and I'm very proud to share my college experience at 'Hard Work U' with those who ask."

Angela (Ussery) Williamson '00 Outstanding Young Alumnus

Angela (Ussery) Williamson is this year's recipient of the Outstanding Young Alumni Award. Graduating in 2000 with a Bachelor of Arts in Mass Communications degree, she is in the process of earning her Master of Arts in Communication from Missouri State University.

Angela currently serves as the Deputy White House Liaison in the Attorney General's office at the Department of Justice. Previously, she served in the First Lady's Correspondence Office and as Senior Press Assistant in the Justice Department's Office of Public Affairs.

Angela's career began at her hometown radio station. She said that this job provided her with great training for thinking on her feet and troubleshooting last-minute changes. She also feels that in this line of work, she learned valuable lessons that prepared her for other positions, including her job as an Admissions Representative at College of the Ozarks.

While a student at C of O, Angela was an Ambassador for the Missouri Farm Bureau and still maintains membership in the organization. She and her husband attend the First Baptist Church of Alexandria, Virginia.

Angela says, "My greatest accomplishment is when someone tells me that I've encouraged them or made a difference. No matter how busy we are in our day-to-day life, we should make time for others. I believe the Lord wants us to serve."

Commenting on the College she says, "College of the Ozarks has had an enormous impact on my life. It wasn't only the Christian influence and strong patriotism; it was also the professors who challenged me, the work ethic that disciplined me, and the lifelong friendships that began there. Looking back, I can't imagine not attending C of O." Further she says, "C of O helped shape my life. It holds a special place in my heart full of good friends and great memories...It will always feel like home to me."

Don Baker is this year's recipient of the Distinguished Service to College of the Ozarks Award. Don graduated from The School of the Ozarks High School in 1950. He went on to Draughon's Business University, and, then, to Missouri State University

where he earned his Bachelor of Science degree in Accounting. He continued his professional education at The American Institute for Property and Liability Underwriters, where he became a Chartered Property Casualty Underwriter (CPCU) and later earned his CLU from The American College.

Don served in the U.S. Army at the Finance Center for Europe in Germany. After serving in the Army, Don became a Cost Accountant during the construction of Table Rock Dam. It was during this time that Don realized the importance of a college degree. After getting his degree, Don worked as a Staff Auditor for Missouri Farmers Association, Explaining operations to a different Board of Directors each week convinced him that he needed to be in the sales field. Don found his vocation at State Farm Insurance Companies as an agent. For 35 years he served the Tri-Lakes area, retiring in 1998.

Don is currently a member of the Board of Trustees of College of the Ozarks, Director of First Community Bank of the Ozarks, Trustee of Skaggs Community Hospital, and Director of Branson Housing Authority-Vice Chairman. He is a member of Branson Masonic Lodge, Abou Ben Adhem Shrine and Taney County Shrine Club, Scottish Rite and York Rite Bodies, Ozark Chapter of CPCU, Ozark Chapter of CLU, and Missouri Pilots Association. Don is a former member of Branson Planning and Zoning Committee, Daybreakers Rotary Club of Branson, former Treasurer of Skaggs Community Hospital Board of Directors, chairman of Branson Pack 93, Boy Scouts of America, and a deacon and trustee at his church, First Presbyterian, Branson.

Professionally, Don's sphere of influence includes being the first insurance agent in the Tri-Lakes area to pursue and obtain the internationally recognized professional designations of CPCU and CLU. This gave him the chance to provide his staff members with training programs that allowed several of them to establish their own successful careers in the insurance industry.

However, Don believes his greatest accomplishment was marrying his wife, Betts, and raising five happy and productive children, Douglas, Dale, Donna, Bryan, and Linda.

Don's success in life was greatly influenced by Dr. Good and Dr. Clark at The School of the Ozarks. Prior to attending S of O, Don's exposure to the needs of the world was limited. According to him, "At S of O, we became aware that a lot of people had started with very little and had become successful. The atmosphere of optimism that was reinforced on a daily basis at Chapel and throughout the campus was an inspiration." Don savs that he feels very fortunate that he attended The School of the Ozarks and that the experiences there definitely shaped his life.

Donald (Don) Ray Johnson '60 JC Distinguished Community Service Award

Donald Johnson is this year's recipient of the Distinguished Community Service Award. Don graduated from The School of the Ozarks Junior College in 1960. He continued his education at Missouri State University, where he received his Bachelor of Science in Education and earned his Master's of Divinity from Southwestern Baptist Theological Seminary in Fort Worth, TX. After college,

he earned his pilot's license with single-engine, instrument, and multi-engine ratings and completed his Missionary Orientation. Later, he went on to Portuguese Language School, Chaplain's Practicum at St. John's Hospital, and North American Mission Board of Disaster Relief Training for Chaplaincy. Recently he attended real estate school.

Don's career began at Crank Drug Company in Springfield, MO. From there he became a sales representative for Ayerst Laboratories and, later, for Eli Lilly Pharmaceuticals. For several years, Don was a missionary pilot and evangelist to Equatorial Brazil. He worked for Lifeway Christian Resources Broadman-Holman Publishing Division as a sales representative in Academic. International, and Christian Book Stores for twenty years and retired last year. This year, he began working as a real estate agent.

Don served in the U.S. Naval Reserves and was active duty for two years as an Air Traffic Controller on the U.S.S. Hancock. His organization affiliations include the Junior Chamber of Commerce, Ham Radio Clubs, AOPA (Aircraft Owners and Pilots Association), and the College of the Ozarks Alumni Association.

For his community, Don has served as Chaplain of the Tennessee Disaster Relief, Missouri Baptist Convention Nominating Committee, Pastor of First Baptist Church in Kimberling City, MO, and Pastor of Burneyville Baptist Church in Burneyville, OK. He has helped build wheelchair ramps with Civitan Service Organization, and with the Tennessee Baptist Disaster relief, worked in New Orleans, LA, Gallatin, TN, and Eufala, OK.

Don is currently a member of Hermitage Hills Baptist Church in

Hermitage, TN. He has preached and promoted missions in various churches, helped renovate a satellite campus church of Hermitage Hills Baptist, taught Sunday School for 18 years in various churches, and gone on seven short-term mission trips to various locations throughout the world. According to Don, "Being open to the Lord's leadership has led to a fulfilling life of wonderful opportunities. This began in my own family when I accepted Christ at age nine. It was nurtured at The School of the Ozarks, and has guided me throughout my life. It has allowed me to travel to 19 foreign countries and most of the United States."

Don attributes his work ethic

to the opportunities he was given at The School of the Ozarks and its lasting impressions that it left on his life. "When I was accepted as a student at S of O in 1958, I never dreamed that I would spend almost six years as a missionary pilot along the great Amazon River in Brazil. I spent about 1,300 hours flying sick people to hospitals, seminary students and pastors into remote areas to start new churches and share the gospel with many who had never heard, and flying missionaries into jungle tribes to translate the Bible into their native languages. The College of the Ozarks gave me a chance to explore new opportunities that I had never even dreamed of before. I saw the sign posted in the chapel

asking, 'Why come ye here?' and that caused me to realize that nothing happens by chance, but that God has a purpose for every life. Outside the chapel there was a plaque proclaiming, 'It is better to run to get ahead, than to run to catch up.' Those have been powerful principles that have influenced my life. They taught me that when you do more than expected, you will be rewarded."

Today, Don resides in Hermitage, Tennessee, with his wife of 41 years, Beth Johnson. They have three grown children, Michael James, Myron Jay, and John Mark.


