

Categories and Eligibility:

- 1. Meritorious Alumni Award for Distinguished Achievements—College of the Ozarks Alumni
- 2. Distinguished Community Service Award—College of the Ozarks Alumni
- 3. **Distinguished Young Alumni Award**—any College of the Ozarks alumnus who has graduated less than twenty years ago and is not older than forty-five
- 4. Award for Distinguished Service to College of the Ozarks—faculty, staff and administration, friends or any other worthy individual.

Guidelines:

- 1. The nominee must be living at the time of notification of the Award selection and be present, if possible, at Homecoming to accept the award.
- 2. Nominees must show current and continued interest in College of the Ozarks.
- 3. Nominees must complete an official nomination form listing dates and achievements.

Selection of awardees is determined by the Honors and Awards Committee, appointed by the President of the Association every two years. The Honors and Awards report of selections is approved by the Alumni Council before awards are published. Nominees' files are kept active for two years following nomination.

Alumni Spotlight: Bob Shackleford '73

Bob Shackleford: Comfort in the Storm

A chaplain from Asheboro stands tall in the aftermath of terror at the Pentagon. In the great western movie tradition, the heroes were always tall. They personified strength of character and dominion over the forces of ignorance or oppression. So if you were casting a real-life hero, your man would be Robert S. "Bob" Shackleford. He stands 6 feet 7 inches in his sock feet.

Yet in Shackleford's case, height was a handicap that cost him his childhood dream. He once imagined becoming an Air Force fighter pilot, a Chuck Yeager-style hero. Then fate—or what he describes as one of the pieces of a puzzle he finally put together - created an alternative dream. As a result, he has

instead piloted the human spirit through one of our country's great tragedies, as one of the National Guard's highest-ranking chaplains.

Now a father and grandfather who targets social issues in his sights, Shackleford has claimed his height as a stroke of good fortune after all. He is sufficiently tall to straddle the worlds of education, counseling, and ministry.

Most recently, a key part of Shackleford's life's work, his knowledge of post-traumatic stress and his counseling skills, helped him shepherd men and women through suffering without parallel following the September 11 terrorist attacks. All of which, he explains, has come to fruition because of a dream denied.

"As a little boy, I saw a picture of my father in an Air Force uniform. It was the most handsome picture I ever saw. I always admired him. He was the best man I ever knew. I always thought I wanted to be a fighter pilot." But it was not to be.

"I was too tall to pull the canopy down over my head in a fighter plane," Shackleford smiles ruefully.

After deciding to pursue the ministry - his second dream - at the Southeastern Baptist Theological Seminary in Wake Forest, Shackleford found himself advancing farther into his own education and toward his third dream of becoming an educator. He studied at the University of North Carolina at Greensboro, earning a master's degree and doctorate in child development and family relations.

"I see those roles—education and ministry—as overlapping, anyway," he smiles from his Randolph Community College office.

"Although I don't go around preaching to students," he jokes. What he does do, he says, is talk about self-efficacy and purpose.

So, with a considerable sense of efficacy, Shackleford didn't sit still when he had realized alternate dreams two and three. Then, there was the matter of yet a fourth unrealized dream that dove-



tailed nicely with his very first. He ultimately joined the Air Force in 1986, after a seminary friend urged him to apply for a reserve chaplaincy. In the past 16 years, he has ascended to wing chaplain for the North Carolina National Guard, a role that gives him senior ranking in the largest National Guard in the nation.

"The role as a chaplain is a wonderful opportunity to minister in ways that aren't ever available to a pastor," he says. He was on call during the crash of [USAir DC-9] flight 1016 in Charlotte in 1994, and he worked with families who suffered losses during Hurricane Floyd in 1999.

The week after September 11, an Air Force commander called him to work with Pentagon victims and their families. "They needed chaplains with training in critical incidents stress management," Shackleford says. He fit the bill, being especially trained to prevent post-traumatic stress reactions among victims and survivors of a disaster.

He points out that more people died at the Pentagon than in the 1995 bombing in Oklahoma City. But what happened in New York on 9/11— the huge numbers of civilian fatalities, the visual impact of the collapsing towers—tended to eclipse the significance of the Pentagon. "People think of military casualties differently than civilian," Shackleford says.

The irony, for him, is that many of the men and women killed at the Pentagon were civilian office workers, people with "photos of their grandchildren on their desks." He glances uneasily behind him at the framed pictures of his own grandkids. "That was something a man who fixed computers of many of the dead spoke about: the pictures," he says. "He knew so many of those who died there."

For two weeks, Shackleford met with the traumatized survivors who were reporting to a workplace still smoldering from the attack. "People were terrified to come to work, but they were on the front line.

Forsythe Fellows Honored



The seventh-annual Forsythe Fellows Luncheon brought over 100 alumni back to the campus on May 3, 2003. The spring weather was beautiful that Saturday with several alumni enjoying a campus tour after the luncheon.

They had to. These people, now more than ever, had to be hyperalert. We had to help them become functional again and resolve the immediate trauma." On Friday, September 14, Shackleford led two Pentagon prayer services. In addition, he used his theological training to brief commanders about the basis of Muslim religions.

In the aftermath of the Pentagon strike, Shackleford realized he needed to draw on all aspects of his education and training, to synthesize his life's work and experience. He moved between trauma counseling and theological briefings, grabbing food and sleep whenever he could.

Shackleford finds deep joy in being a chaplain, rewarded by the sheer diversity of Air Force and National Guard congregations. "They're black, white, Asian, and Hispanic," Shackleford says happily. He also relishes how, in this one critical instance, all are equals irrespective of rank. "Eighteenyear-olds and generals are all sitting together for worship."

After his intense experience at the Pentagon, Shackleford went back to Asheboro where he is Dean of Student Services at Randolph Community College. But duty called again. During his weekend Reserve duty, he helped prepare his unit for deployment. Soon another call came, this time sending him to France for 32 days.

"We have a unit there in Istres that does refueling for military planes, very near the Mediterranean," he says, avoiding direct comment about his purpose there. But there is something he can describe about that area, a story that nearly makes him weep.

The story involves a bomber that was shot down during World War II and crashed into a farmer's field in the heart of wine country. Every year, over Memorial Day weekend, French villagers gather in that field to honor Americans who lost their lives on foreign soil. The names of the airmen are inscribed on a big rock, and pieces of their airplane are attached to the monument. French veterans in wheelchairs, wearing their medals, are brought to the ceremony.

"The consulate general, civilian dignitaries, the retired ambassador to France, the mayor, all sorts of civilian and military dignitaries come together in this field," Shackleford says. "They have an honor guard and band. As the band strikes up, it first plays the American anthem, then the French national anthem. You stand there on a beautiful Saturday morning. You see the French gathered to say, 'Thank you, America."

His eyes moist, Shackleford adds, "Americans don't realize how highly regarded are their efforts by the French." It is the forgiving, compassionate, and soulful leadership model he admires most. His personal movie hero, this big man says, wasn't a western gunslinger or a "top gun" pilot. It was Camelot's King Arthur.

He quotes: "You can break my heart with betrayal, disrupt my lofty ideals with one challenge after another, distract me continuously from all that I am trying to do, bring the chaos of rebellious knights on horseback to trample down my beloved 'round table,' and come against me in bitter war, but you can never kill my dream. You can't have that. Nothing can quench my dream."


